
Envelope 1B



- 4. Only fill out the back if ballots were manually counted




These labels go on the Outside of the counted ballots from the ICE Machine. Place the write-in ballots on the top of cast ballots, then seal box and label.




Envelope 4 and Contents



This envelopes only includes spoiled or voided ballots. Please mark Void and mark through Bar Code. This assures ICE will not read.







This envelopes includes returned absentee ballots from individuals who wanted to vote in person and did not want to mail in or drop in the absentee ballot box. Void materials and ballot.







This label goes on every box with unused ballots




Envelope 7 - Front

This envelope includes the padded envelope with the ICE Memory Card and the red Seal.





